Sensors to the thermowell are used for precise remote temperature measurements of calm and flowing liquids (gases and liquids), for which features of the sensor the thermowell chosen by the customer are suitable. Measurements are possible up to the temperature and pressure determined by the thermowell resistance.

They are intended for explosion hazard environment, group II 2G Ex d IIC T1÷T6 Gb and II 2D Ex tb IIC T=T_{media} Db. The product is marked in conformity with sec. 1.0.5., Annex No. 2 to the Directive to 2014/34/EU. Scope of use of the products is determined by technical documentation for the products.
